In accordance with Supreme Court judgement and directives, guidelines of UGC and State government, Pub Majuli College has formed an Anti-Ragging Cell to adhering to a Zero-tolerance policy on ragging. Any student who is suspected of ragging and is proven to be guilty shall face harsh punishment in accordance with the provisions of Law.

The Guidelines :

1. The Principal of the College will be the Chairperson of the Cell.
2. The cell will consist nine members.
3. The cell will have two senior female faculty members.
4. The cell will have one legal adviser.

Objectives of the Cell :

1. To create awareness about the negative impact of ragging among the students.
2. To create the institution a ragging free zone.
3. To forbid any actions taken by any student whether through words spoken or written, or through an act, that has the effect taunting, or handling a fresher or any student rudely.
4. To keep a close constant eye and vigilance over ragging in order to prevent it from Taking place.
5. To address any ragging related issues immediately and to take any action Recommended by the committee.

Counseling:

The College will provide counseling sessions for the victims of ragging. It is decided to invite professional counselors for the purpose.

Disciplinary Action:

The College will take strict disciplinary actions against those who will be found guilty of ragging. It may include suspension, expulsion and legal action.

The Committee members also asked for the role of parents to prevent ragging.

Finally the chairperson thanked the members for their valuable suggestions and contributions to the meeting. It was decided to implement the above measures immediately. The meeting was adjourned at 12-30 pm.
